The minutes of the previous meeting were reviewed and agreed upon.

At the outset, Dr.Anish Gupta welcomed everyone. Dr.Raji Mishra, Associate Professor (SORT) attended the meeting as a *special invitee*. Dr.Ramachandra Reddy, Dr. Manish Agarwal, Dr.Ankur Jain and Dr.DarpanBhargava had informed about their absence from the meeting. The following points were discussed:

Point 1. Program Outcomes and Course Outcomes. Dr. Anish Gupta suggested that the Course Outcomes need to be redefined (following Bloom's Cognitive Taxonomy) in a way that they are assessed in the two sessional exmas (Internal Exams). This should be followed by analysis and course attainment should be calculated. These shall be for all the courses of both the dental institutes (People's Dental Academy & People's College of Dental Sciences& Research Centre). After Discussions with the Dean, Faculty of Dentistry& HOI's a format shall be circulated. Point 2 & 3. Elective and Interdisciplinary courses. Dr. Anish Gupta asked the Members of the Board to give a list of Elective and Interdisciplinary courses so as to make a common pool. After discussions with the HOI's and Controller of Examinations, People's University and approval by the Academic Council, these courses shall be initiated. Dr. Anish Gupta also briefed the members about introducing Choice Based Credit System. Dr. Raji Mishra briefed the members about the pattern followed in School of Research & Technology (Constituent Unit of People's University) according to AICTE and UGC norms. Dr. Shiva Kumar has agreed to provide support and guidance for the same.

Point 4.Regarding grouping syllabus as must know, desirable to know and nice to know. Dr.Anish Gupta suggested that the syllabus should be grouped under the above mentioned categories as follows: Must Know- 50%, desirable to know-30% and nice to know-20%. All the members agreed the importance of it and have consented for the same. The Dean, Faculty of Dentistry&HOI's shall be briefed about the same and the guidelines shall be formulated. Point 5.Fellowship course in Laser Dentistry. The proposal to start Fellowship in Laser Dentistry was sent by Department of Periodontology (People's Dental Academy) [Reference]

No-PDA/Dean/20/1403 Dated-23 September 2020]. It shall be spread over a period of 9 months. The members discussed it at length. All the members agreed upon the importance of this programm. Dr.Anish Gupta suggested that the word "course" should be replaced by "programm" as per the nomenclature followed by People's University or it can be ommitted. The programmwas approved and shall be carried out in People's Dental Academy.

Point 6.Any other matter. There were 2 proposals of starting Fellowship programms from the Deaprtment of Oral and Maxillofacial Pathology (PCDS & RC) viz: Fellowship in Dental Education[Reference No-PCDS/ESTT/2020/21/533]and Fellowship in Scientific Writing[Reference No-PCDS/ESTT/2020/21/530]. Fellowship in Dental Education shall be for a period of 12 months and Fellowship in Scientific Writing shall be for a period of 6 months. Both the programms were discussed in the meeting. The programms were approved and shall be carried out in People's College of Dental Sciences & Research Centre.
