



ANTI-RAGGING COMMITTEE AND SQUAD

Anti-Ragging Committee to ensure compliance with the provisions of Regulations as well as the provisions of any law for the time being in force concerning ragging; and also, to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.

As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

- ✓ Any act of Indiscipline, Teasing or Handling with Rudeness.
- ✓ Any act that Prevents, Disrupts the Regular Academic Activity.
- ✓ Any activity which is likely to cause Annoyance, hardship, psychological Harm or creates Fear or Apprehension.
- ✓ Any Act of Financial Extortion or Forceful Expenditure.
- ✓ Any Act of Physical Abuse causing Assault, Harm or danger to Health.
- ✓ Any Act of abuse by spoken words, emails, SMS or public insult etc.
- ✓ Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
- ✓ Any unlawful assembly or conspiracy to ragging.

Terms of Members: Two years for nominated faculty members and one year for nominated student members.

Meetings: At least once a year and as and when necessary

Functions:

- ✓ Arrange campaigning, counseling and growing awareness through display or otherwise against the evils of ragging, its severity as a criminal offence and the associated punishments, when found guilty.
- ✓ Conduct enquiry of all reported cases and / or complaints received in any form.
- ✓ Recommend to the BOG through the Director the findings and the punitive action to be taken, if any
- ✓ Evolve and suggest means to take preventive measures against ragging.





During the meeting, the Several Department HODs, and members of various organizing committees (Anti Ragging, sexual harassment, discipline committee) were present.


