



**MEMORANDUM OF UNDERSTANDING BETWEEN PCDS & RC,
BHOPAL AND SAMBHAVANA TRUST, BHOPAL**

The Department of Public Health Dentistry is working in collaboration with Sambhavna Trust for providing dental treatment services. The service has commenced on 1st November 2012 and shall continue for period of 5 years from the date of inception. This memorandum can be terminated by either party giving the other party two months notice in writing.

- The team of doctors from PCDS & RC would be visiting Sambhavna clinic from Monday to Friday.
- The working hours would be from 10.00 AM to 12.30 PM
- The team consists of a MDS faculty and a post graduate with BDS qualification and pursuing MDS.
- On Wednesday the team from Department of Oral & Maxillofacial Surgery would be attending the clinic for speciality treatment.
- We are working for a social cause and only emergency and primary dental services would be provided. For speciality services, the patients will be guided to either visit PCDS & RC or any other dental hospital as per patient's choice.
- When the patient visits PCDS & RC for treatment, the rules of the college will be applicable.
- In case of Peoples General Hospital, only Radiographs would be given a discount and charged at 20/- for IOPAs.
- The services provided include oral health check up and diagnosis, oral health education, oral prophylaxis, simple restorations and extractions.
- Informed written consent would be taken from the patient before any dental procedure and the registered doctor who is operating on the patient is responsible for the patient's treatment. Along with the treating doctor, PCDS & RC, as the primary employer is also responsible for the surgical and other treatment of the patients visiting the dental clinic.

Only the beneficiaries of Sambhavna trust carrying the registered card would be provided with the treatment.

Medicines related to dental procedures will be provided by PCDS & RC. (Mouth Washes & Desensitizing Tooth Pastes).

A report of patient visit and procedure carried out along with the details of doctors and other staff attending the clinic would be sent to the trust every month.
