**Subject: Assessment of Annual Declaration Form and grant of Renewal of Undergraduate seats (MBBS) for the year 2025-26 - regarding.**

Sir/ Madam,

I am directed to refer to the Public Notice issued by UGMEB vide dated 01.11.2024 uploaded on the NMC website on 06.11.2024, directing all medical colleges with valid Letters of Permission (LoP) to upload the details/data of their respective institutions on the NMC portal for the annual declaration, as required under the NMC Act, 2019 and various regulations issued by NMC from time to time, for the grant of renewal of MBBS seats for the academic year 2025-26.

2. Based on the details furnished by your college, the experts assessed the submissions, and accordingly, a Notice dated 14.05.2025 was issued highlighting the following deficiencies observed during the assessment:

- i. Fourteen (14) out of Nineteen (19) departments are deficient in faculty/ Resident/tutor as per AEBAS record data.
- ii. Establishment of LOP date & date of last Increase of seats LOP date mentioned but no PDF.
- iii. Cadaver data deficient.
- iv. Hematology & Biochemistry data Inadequate.

- v. Total no. of death data needs to be verified.
- vi. 10/19 departments are deficient in faculty/residents in self declaration form - Anatomy, Biochemistry, FMT, General Surgery, Microbiology, Ophthalmology, Pathology, Pharmacology, Physiology, Psychiatry.

3. Subsequently, the compliance report submitted by your Institution was also evaluated by the Assessors; however, amongst other deficiencies, following key deficiencies were again highlighted w.r.t. your College/Institution:

- i. Fourteen (14) out of Nineteen (19) departments are still deficient in faculty/Resident/tutor as per AEBAS record data. The reply submitted by the college is non-satisfactory.
- ii. 10/19 departments are still deficient in faculty/residents in self declaration form - as the college claims that faculty deficiency is not there as per 2020 MSR- this reply is non-satisfactory.

Further, it has been observed that during the renewal process for the previous year AY 2024-25, penalty was imposed and conditional renewal was granted in view of the substantive nature of deficiencies in your College.

4. In the physical hearing, your college was represented by the Dean/Principal/Vice-Principal/HoD, who appeared before the Board **on 1st July, 2025**. It is observed that gross and substantive deficiencies in both faculty and clinical parameters were found in your medical college/Institute. And the clarifications furnished by your institution were not found convincing and satisfactory. The college also accepted the deficiencies and assured to fulfill the same within a very short span of time. As per the standards prescribed under the extant regulations, a medical college shall be deemed **grossly deficient** if significant shortcomings are observed in any of the following key parameters:

- I. **Data/Details submitted by the Colleges in Annual Declaration Form on the NMC portal.**
- II. **AEBAS Analysis (Aadhaar Enabled Biometric Attendance System) for the Academic Year 2024-25.**
- III. **Reply of the College Authorities to the Show Cause Notice**
- IV. **Physical Hearing of College Authorities.**
- V. **Verification of Form-16 and Form 26AS as provided by college authority.**

5. Further, it is to convey that the college was earlier cautioned during the academic year 2024-25 that stringent action, as mandated under Chapter-III, Clause-8 of the MSMER-2023 under the heading "Penalties", would be imposed if the deficiencies continued to exist. Despite this, the deficiencies have persisted and no significant improvement has been noted. Since the medical college has been found deficient in one or more of the parameters stated in Paragraph 3 above, the Board has decided to impose penalty of **Rs. Ten Lacs (Rs.10,000,00/-)** and to grant conditional **renewal of 250 undergraduate (MBBS) seats for the academic year 2025-26**. Subsequently, after a gap of two months, a re-assessment of the college will be conducted. If deficiencies are still found to exist, then action as deemed fit **as mandated under MSMER-2023 Chapter-III, Clause-8 (Penalties)** shall be imposed without further notice.

6. As per, it is directed to remit the penalty amount within seven days (7 days) into "**NMC Own Resources, Canara Bank Account No. No. 90682160000025, IFSC code CNRB0019109**" and forward confirmation of payment along with transaction details to [ugrenewal@nmc.org.in](mailto:ugrenewal@nmc.org.in).

7. If you are not satisfied and aggrieved with the decision of the Board, you are free to prefer an appeal before the Commission under Section 9, Chapter IV of the Maintenance of Standards of Medical Education Regulations, 2023, (MSMER, 2023) within sixty days of the issue of this letter.

4. It is mandatory by government medical colleges to contribute **15%** MBBS seats and **50%** of post graduate broad specialties (MD/MS) for All India Quota respectively, to MCC of DGHS for conduction of counselling as per the directions of Hon'ble Supreme Court.
5. It is mandatory to develop a website of medical college/institution and display all the information of college and courses offered as per the guidelines issued by National Medical Commission (NMC) from time to time.
6. This has approval of the Competent Authority.

brought to the notice of National Medical Commission (NMC) or **found during surprise assessment at any stage during the current academic year, your institution is liable, not to be considered for recognition of that degree.** This letter of permission will be revoked for the current academic year if such exigency arises. Besides, National Medical Commission (NMC) is entitled to take all such measure against you and your college/institution as permissible under the law.

4. It is mandatory by government medical colleges to contribute **15%** MBBS seats and **50%** of post graduate broad specialties (MD/MS) for All India Quota respectively, to MCC of DGHS for conduction of counselling as per the directions of Hon'ble Supreme Court.

5. It is mandatory to develop a website of medical college/institution and display all the information of college and courses offered as per the guidelines issued by National Medical Commission (NMC) from time to time.

6. This has approval of Competent Authority.
