

Hon'ble Vice-Chancellor. Dr. V K Pandya welcomed Deans of respective faculties & other members. The proposed agenda was discussed as follows:

- Confirmation of minutes of previous meeting of Standing Committee of Academic Council dated 29/04/2016: Members confirmed the minutes of previous meeting of Standing Committee held on 29/04/2016.
- Discussions regarding opening of Department of Disability Studies: Hon'ble Vice Chancellor requested Dean PCMS, to make a detailed draft proposal of this department with the help of Orthopedics, Ophthalmology, ENT and Pediatrics departments initially and submit to the undersigned at the earliest. The committee has principally approved proposal of opening Department of Disability Studies in People's Hospital, (Action by Dean PCMS&RC).
- 3. Opening of Certificate Courses in People's Hospital: Medical Director, People's Hospital had proposed some certificate courses to commence in People's Hospital in the current session. Dr P R Suresh informed the members that these courses will not have any authenticity as permission from Paramedical Council has not been taken. Hon'ble Vice Chancellor requested the Medical Director to take the permission from the council before 30th October 2016 being cut of date for application. Hon'ble Vice-Chancellor has already informed People's Hospital. (Action by medical Director, People's Hospital).
- 4. Amendments in Ordinances of Nursing Courses namely Ordinance No. 10-B.Sc.(N), Ordinance No. 20-M.Sc.(N) & Ordinance No. 39-Post Basic B.Sc. (N) as per the guidelines of Indian Nursing Council: Dean faculty of Nursing had proposed few amendments in the Ordinances B.Sc.(N), M.Sc.(N) & Post Basic B.Sc. (N) as per the recommendations of Indian Nursing Council, which was approved unanimously by the Council. The amendments will be implemented from the current session itself after publications in Government Gazette. Amendments to be sent to MPPURC for necessary Publications. (Action by D.A.A)

- Approval of Scheme & Syllabus of M. Tech-(Urban Planning): Dean Faculty of Engineering had 5. submitted the Scheme and Syllabus of M. Tech (Urban Planning) to be commenced from July 2017 session, which were also approved. Proposal has already been approved by B.O.M & Governing Body. M.P.P.U.R.C. to be informed (Action by D.A.A. People's University).
- Dr. V K Pandya discussed with Honourable members regarding M:P. Higher Education letter dated 6. 22/08/2016 for the conduction of ATKT Exams within one month of restilts in the 5th and 6th Semesters of Undergraduate and 3<sup>rd</sup> and 4<sup>th</sup> semesters of Postgraduate classes. Controller of Examination then requested that a letter should be sent to Higher Education Department Government of Madhya Pradesh for clarification before implementing it. More clarification was also sought from Dean, faculty of Engineering with the examples of other Universities for conduction of ATKT Exams. (Action by Registrar, People's University).
- Opening of Part time Basic Certificate course of 6 months on Dental Implantology in PCDS&RC: Dear People's College of Dental Sciences had submitted a proposal to the academic department for running this course in PCDS & RC for interns and PG Students. The members were of the opinion that by present proposal only PG students can do this course as interns have a fixed schedule. Finally, this part time certificate course was approved for PG students. Interns can also do this course if done after their routine hours without affecting their basic training. Dean. Faculty of Dentistry also agreed to it. (Action by Dean P.C.D.S&R.C).
- Hon'ble Vice Chancellor informed that since University has completed 5 years, it can now have affiliated 8. colleges under its ambit. He requested all HOIs to give the names of at least five colleges which can affiliate with People's University, if found eligible so that further necessary action can be taken. (Action by H.O.Is).
