SPORTS POLICY

INTRODUCTION:-

Sports and games are integral part of human life as well as important for Human Resources Development. They are also effective way of channelizing the energy of youth for productive and meaningful purposes.

Games and sports are the way of optimum development of individuals through guided instruction and participation in selected total-body sports, rhythmic and Gymnastic activities conducted according to social and Hygienic standards. Sports lead to physical, social and mental integrated development of students.

AIM:-

To lay down guidelines and policy for conduct of games and sports at University and Inter - University level and also to formulate procedures for selection of University Teams for participation at National University Games conducted by Association of Indian Universities.

OBJECTIVES:-

The objectives of the policy are as follows:-

- a) Optimum utilization of sports infrastructure available within constituent units.
- b) Provide equal opportunities to all the students of People's University to participate in games and sports.
- c) Encourage mass participation in sports.
- d) Promote excellence in sports.
- e) Encourage, train and support sportspersons to participate in Inter-University competitions.
- f) Lay special emphasis on strengthening of infrastructure and facilities in Constituent units of the University.
- g) Channelize vibrant youth energy for sports activities and Physical fitness.

APPROACH:-

- a) The University shall work to substantially improve the quality of access to basic sporting facilities such as playing grounds or stadium.
- b) The University shall prepare time-bound and target oriented action plans for the promotion of sports.
- c) Adequate opportunities shall be provided to students to improve their competitiveness by Organizing Championships and Tournaments at various levels right from College and University.
- d) Special attention shall be given to improve the sports in Universities and Colleges. They shall be given incentive to show better performance in West zone / Inter zonal / All India Inter-University (National University Games conducted by Association of Indian Universities) and other Associations.

Since the sports are increasingly becoming technology driven, the University sports department shall identify the equipment that are required for improving standards of performance and physical fitness and promoting excellence in different games and shall strive to introduce them in the University in a phased manner.

INCENTIVES TO SPORTSPERSONS:-

- a) Incentives shall be given to the medal winners of Inter University player(s).
- b) University will give attendance relaxation to the students who take part in Inter University competitions. Relaxation limit to be decided by Academic Council.

SPORTS MEDICINE:-

Sportspersons require special medical attention and treatment and health packages. Colleges and University play a very important role in the promotion of sports and shall continue to support them in every manner for the promotion of sports.

FACILITIES FOR SPORT PERSONS:-

Facilities to be provided for West zone / Inter zonal / All India Inter-University (National University Games) and other Associations Competitions and Coaching Camps for University teams, Managers and Coaches, players shall be as per the norms and regulation.

RECOGNITION AND AWARDS:-

- i. The students of University who win positions in Inter University competitions shall be felicitated by the University.
- ii. The University and colleges which show good potential in any game(s) shall be developed into sporting hubs.
- iii. The University shall make available all its facilities, including coaches, camps and sports infrastructure for improving the skill of their players.
- iv. The University shall also hire coaches on contract basis to provide coaching of desired standard with the clearly defined deliverable. To be elaborated

REFEREES, UMPIRES AND JUDGES:-

The remuneration for referees, umpires and judges invited for conduction of matches during Inter Institute/ West Zone/ Inter Zonal/ All India Inter University tournament shall be as per the norms and regulation of their respective association.

SPORTS COMMITTEE:-

There is a Provision of Constitution of Sports Committee under Statute 16 of People's University. It is desirable that Sports Committee in accordance with above Statute must be constituted. It should also be ensured by Hon'ble Vice Chancellor, who is also ex officio Chairperson of Committee that Committee is performing the functions as per role and responsibilities enumerated in the Statute and the Sports Policy.

The Sports Committee should also frame Rules/Regulations for Sports and Games in the University which should be approved by Board of Management.

PUBLICITY AND MEDIA:-

Publicity and Media play an important role in dissemination of information, popularization and promotion of sports amongst the masses. Manager (Public Relations) will always be involved / informed whenever Sports & Games are being organized by University or University teams are participating in State/ National Level tournament.

BUDGET:-

A tentative budget will be prepared by Sports officer, People's University for conduct of games and sports activities at University level. It will also include the tentative expenditure likely to be included for conduct of games and sports at university level and participation of University teams at Inter - University level. The budget will be placed before the finance committee for approval every year before the commencement of financial year.

CONCLUSION:-

This policy seeks to achieve excellence in sports and encourage students both male and female to participate in sports events and to make full use of available sports infrastructure and develop new infrastructure in the campus.
