
The Hon'ble Vice –Chancellor & Chairman-Academic Council welcomed the members of the Academic Council.

Agenda 1A: Amendment in Ph.D. Ordinance of People's University.

The proposed amendments to the Ph.D. Ordinance of People's University, in accordance with the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations, 2022, were presented and discussed. After deliberation, It was resolved that UGC regulation will be followed and till the time amendment in Ph.D Ordinance no .41 is Gazetted.



Agenda 2: Academic Calendar for the year 2023-24.



Agenda 12: Report on Placement for year 2022-23.



Agenda 16: Approval of Notification for award of Ph.D.


